

**ORDER SETTING 2020 TAX RATE**

WHEREAS, the District has issued and sold certain bonds; and

WHEREAS, the District must levy a tax on all taxable property in the District to provide for payment of interest on and principal of its bonds as said bonds mature; and

WHEREAS, a portion of the tax rolls for the year of 2020 have been finally approved by the Appraisal Review Board; and

WHEREAS, the District has calculated the tax rate necessary to provide for the payment of principal and interest on the District's outstanding bonds as such bonds mature, and further, to provide for the payment of certain operation and maintenance expenses of the District;

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF DIRECTORS OF WEST HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 9 OF HARRIS COUNTY, TEXAS THAT:

I.

The tax rate for the year 2020 shall be \$0.43 per \$100 of assessed valuation, comprised of \$0.364 per \$100 assessed valuation for debt service purposes and \$0.066 per \$100 assessed valuation for operation/maintenance purposes. The District's Tax Assessor and Collector shall take all steps necessary and authorized by law to collect tax as owed pursuant to this Order. Said taxes shall be levied, assessed and collected at the rate of \$0.43 per \$100 of assessed valuation for 2020 as provided for in Chapter 49, Texas Water Code, and all other applicable laws.

II.

The District specifies that the revenues derived from the tax levy shall be recognized in the calendar year ending December 31, 2020.

III.


